Agreement Extension for the Landfill and Scale House

**Operations** 

### **Purpose**

A report to recommend the extension of the Landfill and Scale house Operation at the Peterborough County/City Waste Management Facility.

### Recommendation

That the Waste Management Committee approve the recommendation as outlined in Report WMC19-003 dated February 11, 2019, of the Manager of Environmental Services as follows:

That the Agreement with R.W. Tomlinson Ltd., 5597 Power Road, Ottawa, Ontario K1G 3N4, be extended for the 2020 option year 1. The extension has been offered at an increase of 2.5% from the 2019 contract price (year 7 of the original seven year and four month contract) for the period of January 1, 2020 through December 31, 2020 for \$1,542,119 plus HST of \$200,475 for a total cost of \$1,742,594.

# **Budget and Financial Implications**

Report USWM12-003 awarded RFP P-07-12 to R.W. Tomlinson Ltd for the operation of the Peterborough County/City Landfill Facility (PCCWMF) and Scale house at a total award cost of \$11,384,413.26 for the period of September 1, 2012 to December 31, 2019 inclusive. RFP P-07-12 included three option years, and Tomlinson has offered the first option year Jan 1, 2020 through December 31, 2020 for a total cost of

\$1,569,260 (net of HST rebate). Sufficient funds to accommodate the costs of future year services will be included in both the City and County annual operating budgets.

# **Background**

City Council, at its meeting of June 4, 2012 in considering the May 28, 2012 Report USWM12-003 awarded RFP P-07-12 to R.W. Tomlinson Ltd for the operation of the Peterborough County/City Landfill Facility (PCCWMF) and Scale house at a total award cost of \$11,384,413.26 for the period of September 1, 2012 to December 31, 2019 inclusive.

Tomlinson has provided PCCWMF and Scale house operating services since September 1, 2012. Their service has been reliable, efficient and within budget. Their services have also included a successful mattress recycling program, and the transportation of green waste, cardboard, and recyclable material.

# **Summary**

RFP P-07-12 to operate and maintain the PCCWMF and Scale house has been issued in accordance with the City's Purchasing By-law with the option of three one year extensions, and should be extended for the first option year. The extension should be accommodated in the approved budget as recommended in this report.

Award of the Landfill Engineering and Reporting Services

# **Purpose**

A report to recommend the award of the Landfill Engineering and Reporting Services for the Peterborough County/City Waste Management Facility (PCCWMF).

### Recommendation

That the Waste Management Committee endorse the recommendation as outlined in Report WMC19-004 dated February 11, 2019, of the Manager of Environmental Services as follows:

That Request for Proposals (RFP) P-30-18 for Landfill Engineering and Reporting Services be awarded to WSP Canada Inc., Suite 300, 4 Hughton St S., Hamilton, On L8N 3Z1, for the period of February 14, 2019 to November 30, 2023 at a cost of \$900,736.00 plus \$117,095.68 HST for an estimated total of \$1,017,831.68. The proposal also includes an option to extend for up to three additional years.

# **Budget and Financial Implications**

The cost for the first year of the contract is \$172,398.00 plus \$22,412.74 HST for an estimated total of \$194,809.74, therefore the total after applicable HST rebates of \$175,432.20 can be accommodated within the approved uncommitted balance of the Operating Budget.

Sufficient funds to accommodate the costs of future year services will be included in both the City and County annual operating budgets.

# **Background**

### **Brief Description of the Work**

An experienced consulting team is required to support the Engineering and Reporting requirements of the PCCWMF. The proposed firm must have extensive knowledge and experience developing and operating a landfill site with leachate control mechanisms and landfill gas flares in place. The Consultant shall provide general landfill engineering services, regulatory operational review and annual reporting.

The selected proponent, WSP have provided exceptional services to the PCCWMF in the past, and have extensive industry experience and expertise. .

#### **Procurement Process**

County and City staff prepared and issued Proposal P-30-18 on November 29, 2018, with a closing date of January 10, 2019. The City Procurement processes were followed for the RFP process.

The proposal submissions were reviewed and evaluated by Peterborough County's Manager of Waste Management, the City of Peterborough's Manager of Environmental Services, the Coordinator of Waste Operations and Financial Analyst.

# Summary

RFP P-30-18 to provide Landfill Engineering and Reporting was issued in accordance with the City's Purchasing By-law, and should be awarded to WSP. The award should be accommodated in the approved budgets as recommended in this report.

**Update on Odour Complaints at the County/City Waste** 

**Management Facility** 

# **Purpose**

A report to update the Waste Management Committee on Odour complaints at the County/City Waste Management Facility.

### Recommendations

That the Waste Management Committee approve the recommendations as outlined in Report WMC19-005 dated February 11, 2019, of the Manager of Environmental Services as follows:

- a) That Report WMC19-005 providing an update on Odour Complaints at the County/City Waste Management Facility be received for information; and
- b) That staff be requested to report further on this issue as necessary.

### **Budget and Financial Implications**

There are limited budget and financial implications associated with this report at this time. It is recommended that increased compensatory/remedial, outreach and investigative actions by staff and dedicated Engineering consultants continue.

# **Background**

A community delegation attended the Site Liaison Committee meeting on Tuesday January 29, 2019. Although the number of odour complaints submitted, investigated, and logged through the official Peterborough County/City Waste Management Facility (PCCWMF) complaint registry are not elevated compared to previous years, the delegation presented concerns. Staff corroborated that odour event frequency and severity was slightly elevated late in 2018.

There were nine official complaints in 2018 regarding odour at the PCCWMF and the associated leachate force main to Neal Dr. The following complaints were received and the respective investigation/follow-up were:

5 Neal Dr odour complaints, follow-up:

- design and Ministry approval of the Odour Control facility progresses,
- 100% design is expected in the Spring 2019 with construction tendering to follow,
- chemical application at the landfill and timed pumping reduce the impact of leachate odour.
- 4 General landfill odour complaints, follow-up:
- gas collection vacuum continues to be optimization by PUG,
- gas leaks identified on Cell #3 (North Fill Area) West & South banks and additional intermediate cover has been placed,
- approximately 11 areas of the South Fill Area final cover were repaired/thickened, re-topsoiled, and vegetated,
- impact of abnormal freeze/thaw weather has historically increased odour events,
- each complaint was investigated, and response provided.

# **Next Steps**

The following actions will be taken:

- 1. Staff will continue to investigate complaints received from the public and provide updates and responses.
- 2. Staff will continue routine PCCWMF site surveys, identify odour issues, investigate, and implement recommended solutions.
- 3. Best practices will continue to be followed and implemented to specific odour findings (for example: encouraging PUG to optimize Landfill Gas Collection System, investigating and repairing gas leaks in the cover layers, and actively managing the leachate force-main).
- 4. Residents in the PCCWMF neighbourhood will be canvassed by mail with up-to-date landfill information including contact and complaint reporting details.

- 5. The expert services of the PCCWMF Engineering Services Consultant will be assigned to investigate causes and solutions to the elevated odour issues.
- 6. Updates on PCCWMF odour issues will be provided to the Ministry of the Environment, Conservation & Parks, the Waste Management Committee, and the Site Liaison Committee.
