Representation

Purpose

A report to seek Council approval for representation on the Peterborough Police Service Facility Space Needs Study Steering Committee.

Budget and Financial Implications

There is no cost to approving the recommendation in this report. Funds have been allocated in the 2018 Capital Budget for the Space Needs Study (Project 8-1.02).

Additional funds will likely be required in future capital budgets to implement any recommendations coming from the Study.

Background

The need to undertake a comprehensive Facility Needs Study was included in the Peterborough Police Service 2017 – 2019 Business Plan recently completed as well as the previous Business Plan.

The Board Chair of the Peterborough Police Services Board (PSB) sent a letter, attached as Appendix A, dated November 16, 2017, to the City Clerk asking Council to appoint City representatives to the Steering Committee.

At the PSB meeting of December 5, 2017, Mayor Bennett and Niquel Pritchard Pataki, PSB Executive Assistant, were appointed to the Steering Committee. Other members of the Steering Committee include Deputy Chief of Police - Tim Farquharson, Peterborough Police Association President - Jeff Chartier, Civilian Director - Christie Lee, Inspector - Lynne Buehler and 911 Communications Manager - Alison Kirkland.

It is recommended that Councillor Henry Clarke, Chair of Finance, Sandra Clancy, Director of Corporate Services and Mac MacGillivray, Property and Energy Manager be the City representatives on the Steering Committee and join the others listed above.

As you are aware, the Board just completed its 2017-2019 Business Plan. There are five main areas of focus including infrastructure and technology where the consultants identified the need for the Board to undertake a comprehensive facility needs analysis.

We wish to inform Council that we are moving forward with this project and invite the City to have representation on the Steering Committee.
