Subject:	Report CPCLK15-015 Citizen Appointments to the Police Services Board and Various Advisory Committees

## Purpose

A report to recommend appointments to the Accessibility Advisory Committee, Arenas Parks and Recreation Advisory Committee, Peterborough Architectural Conservation Advisory Committee, the Peterborough Police Services Board and the Peterborough Downtown Business Improvement Area Board of Management (DBIA).

## Recommendations

## Background

Annually, the term of some citizen appointments to various boards and committees expire in November. On September 17, 2015 notice was placed in the local papers and on the City's website regarding the opportunity to apply for vacancies on specific boards and committees. The Citizen Appointment Committee met on October 20, 2015 to interview candidates who applied for the Accessibility Advisory Committee, Arenas Parks and Recreation Advisory Committee, Peterborough Architectural Conservation Advisory Committee, the Peterborough Police Services Board. The Committee makes the Citizen Appointment recommendations, as listed in the report.

On October 15, 2015 the staff received correspondence from the Peterborough Downtown Business Improvement Area Board of Management indicating a vacancy on the Board. The Peterborough Downtown Business Improvement Area Board of Management respectfully requests approval from City Council at this time to fill the vacancy.
