Accessibility Reviews

a) Application for Site Plan Approval, SPC-947, 33 Leahy's Lane (proposed construction of a three storey residential apartment buildings with total of 42 dwelling units)

Presented by Keith Payne, Urban Design Technologist

Summary of recommendations from the Built Environment Sub-Committee:

- 1. Provide mobility scooter parking and storage
- 2. Increase size of elevator to enhance accessibility (e.g. fit a mobility device)
- Include transfer space in the bathroom adjacent to the toilet in the accessible suites
- 4. Washrooms in accessible suites should strive to meet the requirements of commercial standards for accessible washrooms
- 5. Reinforce wall corners in accessible suites
- 6. Consider moving the entrance door in the accessible suites closer to the kitchen to create a clear path of travel
- 7. Ensure clear path of travel along walkways, free from overhanging car bumpers
- 8. Consider poured concrete patios, in lieu of 2x2 patio slabs
- 9. Include tactile indicators where access aisles intersect with the walkway
- 10. Provide no step connection from patio to accessible suites
- 11. Do not incorporate sliding glass patio doors in accessible units
- Make sure electrical outlets raised and light switches lowered in accessible units. Put light switches at 1100 mm. Receptacles 600 mm above the floor
- 13. Include one accessible receptacle in all units
- 14. Include strobe lights on all smoke alarms in the units.
- 15. Ensure there is an accessible path of travel to the City's sidewalk
- 16. Ground floor common room entrance exterior patio door requires clear space of travel on latch side of the door

Business Arising from the Previous Minutes

a) Accessibility Site Plan Checklists

Sadie Norrad, Accessibility and Communication Specialist presented a draft Accessibility Site Plan Checklists to the Committee
