Purpose

A report to recommend City staff be authorized to respond to Havelock-Belmont-Methuen that the request cannot be responded to at this time and is pending the outcome of ongoing discussions with the Township of Douro-Dummer.

Recommendation

That Council approve the recommendation outlined in Report CPFS15-020, dated May 11, 2015, of the Director of Corporate Services as follows:

That City staff be authorized respond to Havelock-Belmont-Methuen that the request cannot be responded to at this time and is pending the outcome of ongoing discussions with the Township of Douro-Dummer.

Budget and Financial Implications

There are no budget and financial implications at this time.

Background

On March 20, 2015, the City received notice from Chief Rodd that the Township of Havelock-Belmont-Methuen (HBM) had requested costing on policing the Township (Appendix A). The Township had signed a six month contract with the OPP and is interested in obtaining a cost estimate from the City before committing to a long term contract.

Such a police arrangement is allowed under Section 6.1(1) of the **Police Services Act** which states "The councils of two municipalities may enter into an agreement for the provision of police services for one municipality by the board of the other municipality, on the conditions set out in the agreement, if the municipality that is to receive the police services is contiguous to the municipality that is to provide the police services or is contiguous to any other municipality that receives police services from the same municipality".

Since HBM is not contiguous to the City geographically, the request must be put on hold pending the ongoing discussions with the Township of Douro-Dummer.
