Peterborough Public Library MEMBERSHIP POLICY

1. INTENT

- 1.1. The Peterborough Public Library shall provide, free of charge, access to and the use of materials and information services within the library in accordance with the Public Libraries Act R.S.O. 1990, Section 23, and Subsections 1.2.
- 1.2. All library material shall be available to persons of all ages.

2. FREE MEMBERSHIPS

- 2.1. The lending services of the Peterborough Public Library are available with out charge to persons of all ages residing or owning a business or property with in the boundaries of the municipality of the City of Peterborough. Institutional memberships are also available.
- 2.2. In the spirit of cooperation, the Peterborough Public Library Board has granted free memberships to students residing outside of the City of Peterborough but attending a local, publically funded high school, college or university. Free membership has also been extended to high school and junior high school students of schools belonging to KLCIC (Kawartha Lakes Library Information Consortium).

3. PAID MEMBERSHIPS.

3.1. Peterborough Public Library lending services shall be available to other persons upon payment of a fee. This policy shall be in compliance with the Public Libraries Act R.S.O. 1990, Section 23, and Subsection 3(c). Current fees are listed in the Regulations.

4. CONTRACTUAL AGREEMENTS

4.1. The Peterborough Public Library may also establish mutually agreeable borrowing arrangements with contracting municipalities or reciprocal borrowing with surrounding townships. The terms of such agreements shall be ratified by the Board.
