Committee; Museum and Archives Advisory Committee and the Peterborough Architectural Conservation Advisory Committee. Legislative support entails, attending meetings, preparing agendas, recording minutes and providing guidance to the Committee regarding meeting procedures. As the Clerk's Office will provide legislative support changes to Advisory Committee documents must be conducted to standardize the way that all Advisory Committees conduct business, and to ensure compliance with the procedure by-law.

The proposed procedure by-law includes sections specific to Advisory Committees and provides a framework for how committee meetings should occur. On September 14, 2009 the proposed procedure by-law was tabled and is currently being discussed by Council.

On August 19, 2009 a preliminary version of the Advisory Committee presentation was delivered to staff representatives associated with the Advisory Committees. Based on the discussion that occurred, a refashioned presentation was delivered to the Chairs and Vice-Chairs of the Advisory Committees, on October 27, 2009.

At the request of the staff involved with the Advisory Committees, the presentation and a high level overview, will be tabled at all Advisory Committees, the first meeting that the Clerk's Office attends in a legislative capacity.
