## **Purpose**

A report to recommend that the PACAC review the proposed changes and additions to the heritage section of the draft Official Plan.

## **Recommendations**

That the PACAC approve the recommendations outlined in Report PACAC16-030, dated September 1, 2016 of the Heritage Resources Coordinator, as follows:

- a) That the PACAC review the revised draft of the heritage section of the draft Official Plan as put forward by its sub-committee and HPO staff;
- b) That the Chair be directed to provide comment to the Planning Division based on the review by the committee.

## **Budget and Financial Implications**

There are no budgetary or financial implications associated with this recommendation.

## **Background**

In 2012, an ad-hoc committee of the PACAC was convened to research and provide recommendations on appropriate heritage content as part of the City's review and update of the Official Plan (OP). The Committee undertook a scan of OPs across

Ontario and produced a comprehensive brief which was approved by the PACAC and provided to the Planning Division (Appendix A). The submission provided has helped to inform the current draft of the Official Plan that is now publicly available for review and comment. <http://www.peterborough.ca/AssetFactory.aspx?did=37881>

At its meeting of May 5, 2016, the PACAC passed the following motion:

- a) That the PACAC undertake a formal review of the proposed amendments to the Official Plan as they relate to heritage,
- b) That a sub-committee be struck to review the Draft Official Plan and bring suggestions back to the Committee at the June meeting for review, and
- c) That Paul Lumsden, Kaes Vanderkooy and Stewart Hamilton be appointed to the sub-committee.

Following a meeting of the sub-committee on May 17, 2016, the PACAC passed the following motions at its meeting of June 2, 2016:

- a) That the PACAC review the suggested changes and additions to the heritage section of the draft Official Plan as put forward by its sub-committee; and
- b) That before final submission is made to Planning Division, revisions be circulated to Committee for comment.

The draft contained in Appendix A of this report puts forward for consideration a revised heritage section of the draft Official Plan. In order for this draft to be relevant to the Official Plan process, staff are recommending that comment be provided to the Planning Division by the Chair at the earliest possible date.
