# Background

#### **Doors Open Peterborough**

Doors Open Peterborough was held on Saturday, May 6. The event recorded approximately almost 3,000 site visits with particularly strong turn-outs at the Peterborough County Court House and the Peterborough Canoe Museum. Surveys were collected from a number of visitors and will be analyzed in the coming weeks to assist in the planning for Doors Open Peterborough 2018. The HPO wishes to thank all members of the PACAC for their assistance leading up to and during the event.

#### Heritage Hunt

The 2017 Heritage Hunt was published in the Peterborough Examiner on Thursday, April 6, 2017. The final date for submission of answer sheets was Friday, May 12. A total of 27 answer sheets were submitted by both individuals and groups. The winners have been identified and were recognized in the Peterborough Examiner, along with a list of the answers, on Thursday, May 18.

**Peace Keepers Memorial** – The first round of judging of the submissions for the Peace Keepers Memorial took place April 26, 2017. Nearly 30 submissions were reviewed and three have been short listed. The review of the short listed submissions will take place on June 5<sup>th</sup>, 2017.

The Planning Division of the Corporation of the City of Peterborough has received a Zoning By-law Amendment for the properties municipally known as 475 George St. N. (former YMCA) and 175 Murray St. (Murray Street Baptist Church).

**Development Description:** The applicant proposes to permit residential dwelling units on the ground floor of the proposed redeveloped property at 475 George St. N. The applicant further proposes to amend the zoning of a portion of the lands at 175 Murray St. in order to sever and consolidate it with the lands at 475 George St. N. to provide additional on-site parking related to the proposed development.

**Recommendation by Staff:** The Committee may wish to comment if they feel that there is an impact on the heritage attributes of the Murray Street Baptist Church. The Committee may also wish to comment on the proposal to allow ground floor residential units.
