Lieutenant Governor's Ontario Heritage Award for Community Leadership - On Friday, February 25, 2011 The Mayor accepted, on behalf of the City, the prestigious Lieutenant Governor's Ontario Heritage Award for Community Leadership. The award was presented by the Honourable David Onley, Lieutenant Governor of Ontario and Dr. Thomas H.B. Symons, Chair of the Ontario Heritage Trust, at a Ceremony at Queen's Park. The award is given to municipalities in three size categories for outstanding contributions to the identification, preservation, protection and promotion of Ontario's heritage. Peterborough has won in the 50,000 to 125,000 population category.

Market Hall- Construction is due to be completed by the end of March.

Heritage Week- Heritage Week in Ontario was launched at a ceremony on February 18th at the Great Hall at Trent University. The Honourable Michael Chan, Minister of Tourism and Culture was in attendance as well as Dr. Thomas H.B. Symons, Mayor Bennett and member of the Ontario Heritage Trust staff and Board of Directors. The event included a 'heritage expo' that included over 25 local groups showcasing their activities. Sheryl Smith chaired the ad hoc committee charged with organizing a week of events in the region celebrating heritage activities and 15 events took place over the week.
