Heritage Preservation Office Report

PURPOSE

BUDGET AND FINANCIAL IMPLICATIONS

There are no budgetary or financial implications associated with the recommendation.

BACKGROUND

Designations- Research for new designations is currently underway.

HPTRP- On October 3, 2011 Council approved the staff recommendation to provide an exception under the Heritage Property Tax Relief Program (HPTRP), allowing 788 Aylmer Street North (The Copping Cottage) and 651 Gilmour Street (The Campbell-Hatton House) to participate in the program.

Doors Open 2011- Doors Open took place on September 24-25, 2011. Monica Moran filled in for Sheryl Smith and coordinated activities.

Young Canada Works – Vanessa Runions has completed the cultural mapping survey project for the City. The information collected will be used to form an update of the City's municipal cultural map.

Turnbull Plaque – The Turnbull Plaque was unveiled at a ceremony at the Turnbull Medical Building on September 22, 2011 with approximately 20 people in attendance. Elwood Jones spoke on the history of the building.

Municipal Cultural Plan- The Open House for the Municipal Cultural Plan has been postponed until the 19^{th} of October. It will now be held at the Knights of Colombus Hall from 4:00-7:00 pm.

Confederation Square- Four interpretive panels have been created by Malcolm Goodwin for the City, presenting the history of Confederation Square from its beginnings as a burial ground to the present. They will be enamel steel panels similar to those in Millennium Park and will be located at the four corner entrances. They are scheduled to be installed in early November.
