# **BUDGET AND FINANCIAL IMPLICATIONS**

### **BACKGROUND**

**Heritage Researcher-** Interviews have been conducted for the Heritage Researcher position. A staffing announcement will be made by mid- March.

**Municipal Cultural Plan (MCP)** - The presentation of the final draft of the MCP has been postponed to the April 16th Committee of the Whole meeting so that the draft plan can be reviewed and endorsed by the Arts, Culture and Heritage Advisory Committee.

**Creation of a Culture Council –** A workshop will be held on April 28, 2012 for the community to begin the process of creating a Culture Council. The Culture Council will be an arms length community body supporting arts, culture and heritage organizations within the community. The Council will compliment the work of the Arts, Culture and Heritage Advisory Committee but will operate independently of the municipality.

**Proposed Amendment – Development Description:** Proposed mixed use development incorporating the former YMCA building, with 92 residential suites and 48 dwelling units in an eight story building, including 1,556 sq. m of gross commercial square metres on the first floor.
