## **BUDGET AND FINANCIAL IMPLICATIONS**

### **BACKGROUND**

**Letterhead –** The new PACAC letterhead, envelopes, and business cards have arrived. The total cost was \$508.50 which is under the budgeted \$600.

**Designations** – The HPO is continuing research on several properties that will be presented to PACAC for consideration at the May 2013 meeting of the Committee.

**Doors Open –** Event information is now available online on the Doors Open Ontario website. The lure brochure created by the Ontario Heritage Trust will be distributed in Peterborough This Week on April 19<sup>th</sup>. The Doors Open Peterborough Committee has also begun advertising for the event. The Kick Off will be held on Thursday April 25<sup>th</sup> at the Canoe Museum.

**Martha Kidd Commemoration Project** – The ad hoc committee met on March 25, 2013 to begin framing the scope of the project.

**PCVS** - Staff is meeting with representatives of the school board to discuss the elements of the building to be included in the designation brief for PCVS.

**London Street Generating Station –** The PACAC chair has forwarded a letter to Peterborough Utility Services with the concerns of the Committee regarding the design of the new building.

**Proposed Amendment – Development Description:** The City is proposing to amend Schedule J – Central Area of the Official Plan to expand the boundary. The effect of this amendment is to re-designate the lands between McDonnel Street and Hunter Street West, east of Bethune Street, adjacent to the westerly boundary of the Commercial Core, from the Transitional Uses Area to the Commercial Core Area. The proposed amendment would harmonize the Commercial Core Area as set out in Schedule J, with the Urban Growth Centre as set out in Schedule A-1 – City Structure of the Official Plan.
