## **Expanding the Heritage Register**

Heather's initial step was to locate areas in outside of Schedule J that contain properties of high cultural heritage value and interest. She accomplished this by cross-referencing historical and modern maps to identify early areas of settlement outside of Schedule J. Any areas that appeared settled on the historical maps were added to her survey list.

Heather also examined areas that had one or more designated properties, but for which no large-scale evaluations had been undertaken, such as Burnham Street in East City. The internal heritage resources map was also a useful tool for the identification of properties with larger boundaries than others in the immediate vicinity. This provided another indication of properties that might be worthy of evaluation.

Field-work undertaken consisted of traversing key neighbourhoods on foot to closely examine architectural features. Heather attempted to identify buildings that clearly exemplified a particular architectural style and retained most of their original features. She also looked for buildings that were stylistically rare or had unique features. Other buildings identified included, elementary schools built almost a century ago that display classic architectural features; modern additions by well-known architects, and a large church in the south end of downtown that had not previously been evaluated

The list of evaluated properties was then reduced to any property that scored above 55. Heather then undertook historical research on these properties using established reference files at the HPO, Peterborough City Directories, and Land Registry Records. The proposed register combines buildings that Heather evaluated with previously evaluated 'Category A' buildings from Schedule J that have yet to be designated.

Based on her work over the course of the fall, Heather was able to identify a possible 36 properties for inclusion in the Register. The list is as follows:
