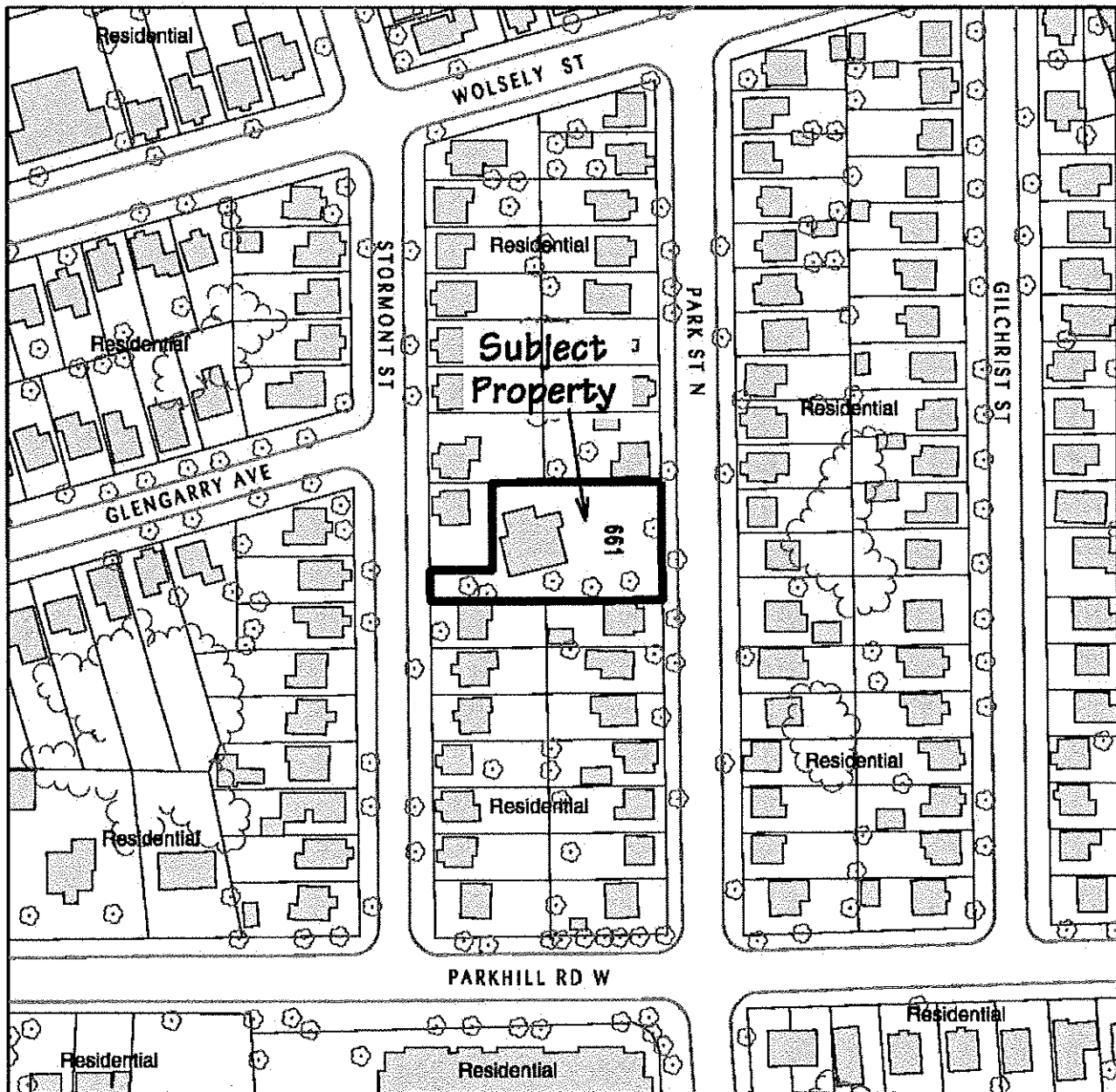

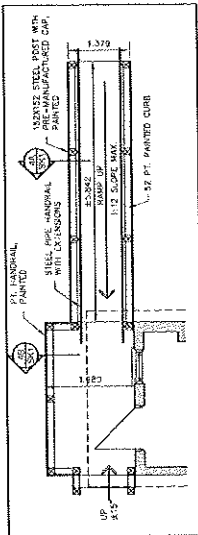

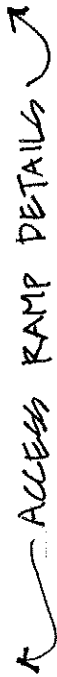

Holding Symbol has been satisfied;

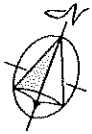
THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL

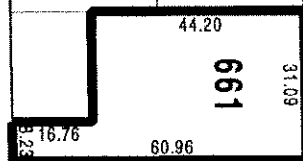
