Removal of 'H' - Holding Symbol from the Zoning of the

Property at 791 Stocker Road

PURPOSE

A report to recommend the removal of the 'H' – Holding Symbol from the zoning of the property at 791 Stocker Road.

RECOMMENDATION

That Council approve the recommendation outlined in Report PLPD13-061 dated August 26, 2013, of the Manager, Planning Division, as follows:

That the property at 791 Stocker Road be rezoned from SP.295-266-(F)-'H'-Residential District to SP. 295-266-(F)-Residential District in accordance with Exhibit 'C' attached to Report PLPD13-061.

BUDGET AND FINANCIAL IMPLICATIONS

There are no budget or financial implications arising out of the recommendation to remove the 'H' – Holding Symbol from the zoning of the subject property.

BACKGROUND

The subject property was rezoned in August of 2011 from R.1, 4h, R.2, 4h- Residential District to SP.295-266-(F)-'H'-Residential District to permit the use of the property for a triplex with site specific regulations related to parking, driveway width, width of landscaped strip and ceiling height of the basement unit (Zoning File: Z1107, Planning Report PLPD11-050).

The conditions imposed for the removal of the 'H' – Holding Symbol from the zoning of the property were as follows:

- i. Site Plan Approval is granted for the subject property;
- ii. Confirmation from Fire Services and from the Building Division, that the units comply with the requirements of the Ontario Building Code and the Ontario Fire Code;
- iii. Payment of cash-in-lieu of parkland for the third unit; and
- iv. Payment of all applicable development charges for the third unit.

Site Plan Approval has been granted. Fire Services and the Building Division have confirmed that the units comply with the requirements of the Ontario Building Code and the Ontario Fire Code. Further, in accordance with the conditions of the removal of the 'H'-Holding symbol, a parks levy and development charge payment have been deposited.

SUMMARY

The conditions associated with the removal of the 'H' – Holding Provision with respect to the zoning of the property at 791 Stocker Road have been satisfied. The site plan is attached as Exhibit 'B' to this report.



Property Location: 791 Stocker Rd




