Removal of 'H' - Holding Symbol from the Zoning of the

property at 424 Sheridan Street

PURPOSE

A report to recommend the removal of the 'H' – Holding Symbol from the zoning of the property at 424 Sheridan Street.

RECOMMENDATION

That Council approve the recommendation outlined in Report PLPD13-069 dated October 7, 2013, of the Manager, Planning Division, as follows:

That the property at 424 Sheridan Street be rezoned from C.6-'H'-Commercial District to C.6-Commercial District in accordance with Exhibit 'C' attached to Report PLPD13-069.

BUDGET AND FINANCIAL IMPLICATIONS

There are no budget or financial implications arising out of the recommendation to remove the 'H' – Holding Symbol from the zoning of the subject property.

BACKGROUND

The subject property was rezoned in June of this year from R.6-Residential District to C.6-'H'-Commercial District, to permit the use of the property for a mix of commercial and residential uses, in accordance with the Central Area – Commercial Core policies of the Official Plan (Zoning File: Z1306, Planning Report PLPD13-041).

The granting of Site Plan Approval is the only condition for the removal of the 'H' – Holding Symbol from the zoning of the property.

Site Plan Approval has been granted for the development. The retaining walls and building access features were constructed before the property was re-zoned. As a result, the site plan review only had to address protection across the tops of retaining walls and the layout of parking on the property.

SUMMARY

The condition associated with the removal of the 'H' – Holding Provision with respect to the zoning of the property at 424 Sheridan Street has been satisfied. The site plan is attached as Exhibit 'B' to this report.




