Accessibility Reviews

a) Application for Site Plan Approval, SPC-956, 1850 Technology Drive, McIntosh Perry Consulting Engineers Ltd. Proposed construction of a one storey, 2014 sq.m. gross floor area facility for the sales and servicing of heavy equipment.

Summary of recommendations from the Built Environment Sub-Committee:

- 1. Ensure the accessible parking spots include a 1.5m access aisle with a curb cut where the aisle meets the walkway
- 2. Include a walkway to the street that could connect to a future sidewalk
- 3. Relocate the door operator that allows for adequate space
- 4. Include an accessible picnic table
- 5. Ensure adequate lighting for parking, walkway and signage areas
- 6. Include column style push buttons
- b) Notice of Application for SPC-958, 1460 Lansdowne Street West, Kevin M. Duguay. Proposed removals, renovations and additions to existing buildings.

Summary of recommendations from the Built Environment Sub-Committee:

- 1. Ensure adequate lighting for parking, signage areas and walkways (especially covered walkway)
- 2. Include a walkway to the current sidewalk
- 3. Upgrade stairs to meet current Ontario Building Code
- 4. Include Type A parking spots
