# General Committee Report No. 2 Meeting of February 11, 2019

To the Council of The City of Peterborough for consideration at its meeting held February 25, 2019

The General Committee as a result of its meeting held on February 11, 2019 recommends as follows:

### 1. By-law to Authorize Borrowing \$15,000,000 for 2019 Current Expenditures Report CLSFS19-012

That Council approve the recommendation outlined in Report CLSFS19-012 dated February 11, 2019, of the Commissioner of Corporate and Legislative Services, as follows:

That a by-law be enacted to establish a \$15,000,000 borrowing limit for the 2019 year to finance current expenditures.

### Citizen Appointments – City of Peterborough Holdings Inc. and Peterborough Distribution Inc. Report CLSCLK19-005

That Council approve the recommendations outlined in Report CLSCLK19-005, dated February 11, 2019, of the Commissioner of Corporate and Legislative Services, as follows:

- c) That a By-law be adopted authorizing Council to exempt the property at 461 Paterson Street, Peterborough from property tax levied for municipal and school purposes for a period of 10 years, as a Municipal Housing Facility in accordance with By-law Number 12-094;
- d) That staff be authorized to negotiate the specific terms and conditions of a legal agreement with ECE Living Ltd. pending confirmation from the Ministry of a revised notional allocation.
