November Heritage Preservation Office Report

Purpose

A report to advise the PACAC on the monthly activities of the Heritage Preservation Office (HPO) for September and October 2019.

Recommendation

That the Peterborough Architectural Conservation Advisory Committee approve the recommendation outlined in Report PACAC19-052, dated November 7, 2019 of the Heritage Resources Coordinator, as follows:

Budget and Financial Implications

There are no budgetary or financial implications associated with the recommendation.

Background

Doors Open 2020 – The Doors Open Committee met in October to discuss planning and hosted an information session and Q&A presented by the Ontario Heritage Trust. Municipalities and Municipal Heritage Committees/Historical Societies within the county were approached regarding a regional collaboration for Doors Open 2020, and they were invited to the information session.

Citizens' War Memorial Committee Meeting- At their August 29, 2019 meeting, the Citizens' War Memorial Committee passed the following motion related to the War Memorial:

Motion 19-09-02: Moved by Pierre Brunet, Seconded by Dave Edgerton

That steps be taken toward correcting the Citizens' War Memorial including: Adding missing names, removing names that appear in error and correcting any other errors or omissions. Carried.

Because the War Memorial is situated in Confederation Square, a designated heritage property in the memorial is an identified heritage attribute, alterations to the memorial must be approved by the PACAC.

Heritage Conservation District Signage - In November 2016, the PACAC requested that a capital allocation be made for the provision of affinity signage in the Avenues and Neighbourhood Conservation District. Many municipalities identify the boundaries of heritage conservation district with such signage.

In 2019, a capital budget allocation of \$25,000 was made for this signage. Staff have researched options for signage and have concluded that street name blades with decorative posts should be purchased in 2019. Each sign blade will cost approximately \$115 + HST + installation. Additional interpretive material will be created for the main street corners of the District for installation in the spring of 2020. The final cost and design of the interpretive material has yet to be formalized.
