## **Purpose**

## **Budget and Financial Implications**

There are no additional budget and financial implications of the recommendation.

## **Background**

The Finance Committee is scheduled to review the 2020 Draft Budget during the week of January 13, 2020. Tuesday, January 14, 2020 has been set aside to review budget requests from outside Boards and Agencies. The Finance Committee will resume its review of City departments on Wednesday, January 15, 2020.

Included on page 210 of the 2020 Draft Budget Highlights Book is a high-level summary of information presented by GPIC.

The 2020 Budget request is the second year of a three-year funding agreement with GPIC which includes \$140,000 per year for 2019, 2020 and 2021.

The GPIC budget, appended to this report, currently shows a deficit as funds from a further source are still expected. If the funds do not materialize, the expenses will be reduced to ensure a balanced budget.

If requested, representatives from GPIC will provide further information on January 14, 2020.
