Removal of "H" - Holding Symbol from the zoning of the

property at 482 Mark Street

Purpose

A report to recommend the removal of the "H" – Holding Symbol from the zoning of the property at 482 Mark Street.

Recommendation

That Council approve the recommendation outlined in Report IPSPL20-015, dated September 8, 2020, of the Commissioner of Infrastructure and Planning Services, as follows:

That the property at 482 Mark Street be re-zoned from **R.3**, **7c**, **10l**, **14h**, **16b**, **20a** – **292** – **H** to **R.3**, **7c**, **10l**, **14h**, **16b**, **20a** – **292** in accordance with Exhibit "C" attached to Report IPSPD20-015.

Budget and Financial Implications

There are no budget or financial implications arising out of the recommendation to remove the "H" – Holding Symbol from the zoning of the subject property.

Background

The subject property was rezoned in September, 2014, from R.1, R.2 - Residential District to the R.3,7c, 10l,14h,16b,20a – 292 – H-Residential District, to permit the conversion of the upper 1 ½ storeys of a former industrial building at the rear of the property to a single dwelling unit. The owners are continuing to use the first floor of the former industrial building as a home-based business (carpentry shop).

The conditions for the removal of the "H" – Holding Symbol were as follows:

- Site Plan Approval is granted for the subject property;
- ii) Payment of cash-in-lieu of parkland for the third unit; and
- iii) Payment of all applicable development charges for the third unit.

Summary

All of the conditions associated with the removal of the "H" – Holding Symbol from the zoning of the property at 482 Mark Street have been satisfied. Accordingly, it is recommended that a By-law be passed to remove the "H" Holding Provision from the zoning of the property.




Exhibit B - Site Plan, Page 1 of 1


