Circulations Received for Comment

File No: Z2003 Proposed Zoning By-law Amendment - 670 Hastings Avenue

Development Description: The Owner is seeking to re-zone the property to permit up to three dwelling units on the property comprised of the main dwelling and two one-bedroom units in the detached accessory building.

Recommendation by Staff: No comment required

File No.: Z2106 Notice of Complete Application for Zoning By-law Amendment - 2077 Ashburnham Drive and for a portion of the property at 2011 Ashburnham Drive (Johnson Park).

Development Description: The Canadian Canoe Museum (CCM) is planning to relocate from their existing facility at 910 Monaghan Road to a new facility alongside the Trent-Severn Waterway. In January 2021, Council authorized staff to negotiate the conveyance of Johnson Park located at 2077 Ashburnham Drive, and part of 2011 Ashburnham Drive, to house the new museum facility. To facilitate the property transaction, Council authorized staff to initiate a re-zoning of the property prior to sale.

Johnson Park is located along the east shore of Little Lake and the north bank of North Meade Creek (also known as Whitlaw Creek). The park is approximately 2.14 ha in area and has approximately 145m of frontage along the west side of Ashburnham Drive, directly across from Eastgate Memorial Park. The property is partially tree-covered, is partially subject to flood plain conditions, and is traversed by the Trans Canada Trail along the Little Lake shoreline. The property is currently vacant save and except for two boat storage containers located along the trail that are operated by the Peterborough Canoe and Kayak Club. The property is bound by the Parks Canada's Trent-Severn Waterway office to the north, Ashburnham Drive to the east, North Meade Creek and Beavermead Park to the south, and Little Lake to the west.

Recommendation by Staff: Archaeology has been completed on the site. No comment required

File Number: SPC 995 - 159 Aylmer Street North

Development Description: The applicant is proposing site improvements to facilitate the reuse of the existing two storey building for the purpose of a clinic and a residential dwelling unit. There are no proposed changes to the building footprint. Modifications to the existing parking area and on-site walkways will be incorporated to enhance accessibility and provide barrier free access. The property is zoned for the proposed use.
