The Municipal Cultural Plan (MCP) is the City's master plan to strengthen Peterborough's cultural sector, build a prosperous creative economy and establish culture as an important pillar of city-building. Accomplishments of the MCP'S strategic objective requires collaboration across all City department, the integration of culture into formal policies, plans and projects and building productive working relationships with.

- 2) Strengthen the Arts
- 3) Strengthen Heritage
- 4) Strengthen Downtown as a Cultural Hub
- 5) Incorporate Culture in all Neighbourhoods
- 6) Encourage Inclusivity and Facilitate Diversity
- 7) Build Capacity of the ACH Division

The potential gaps in the plan will be highlighted and provide the opportunity to start discussions on the next steps for cultural planning in Peterborough.
