**Citizen Appointments to Various Committees** 

## **Purpose**

A report to recommend citizen appointments to various committees.

## Recommendations

- f) That Oliver Fuchs and Richard Cherney be appointed to serve as members of the Airport Strategic Initiatives Committee with terms until November 30, 2022.
- g) That Doug Armstrong and Kate Ahrens be appointed to serve as members of the Airport Strategic Initiatives Committee with terms until November 30, 2023.

## **Background**

Ads for these vacancies were placed in the Peterborough Examiner and Peterborough This Week on March 18, 2021, as well as posted on the City website. Applications were received from 47 individuals.

The Committee met electronically on Tuesday, May 11 and Monday, May 17, 2021 to conduct the virtual interviews. The Committee makes the Citizen Appointment recommendations, as listed in the report. As Advisory Committees do not meet in July or August, the appointees first meetings will be in September.

The recommendations in this report will come forward to City Council for approval on June 28, 2021.
