- 2. An increase of 2.75% to the Service and Community Investment and Project Grant Programs (ACH component), an increase in line with the 2022 tax rate increase.

a) Arts, Culture and Heritage Advisory Committee (subcommittee including the council member(s) appointed to ACHAC) to work with City staff to identify specific financial investments, stimulus measures and City/arts sector partnerships and collaborations to provide support and to address on-going revenue challenges for arts organizations, help the sector prepare for safe and successful re-opening, and prevent permanent closures and loss.

b) Arts, Culture and Heritage Advisory Committee (subcommittee including the council member(s) appointed to ACHAC) to work with City staff to implement improvements in some of the key arts, culture and heritage plans, policies, processes, and practices at Peterborough City Hall to strengthen response to the COVID-19 pandemic and future crises. Areas to be assessed should include building resiliency.

Official Plan Comments

- a) That the OPU vision statement (2.1.1) include mention of contemporary arts and culture.
- b)That the OPU specify that arts and culture have distinct and relevant arts and culture development policies. The should include arts and culture community benefits bylaws/policies, and also arts and culture community development plans.
- c) That the OPU include targeted strategies regarding the preservation and enhancement of physical spaces for the following purposes: the production of arts and culture, the presentations of arts and culture, and for housing for economically vulnerable artists.
- d)That the OPU include language and policies that enable the city to explore notfor-profit land acquisitions, tenure, and development, with or without partnerships – including initiatives such as community and creative land trusts.
