Funding for CMHA and the Mobile Crisis Intervention Team Program, Report CSSS24-001

Next Generation 9-1-1 Update, Report FCSIS24-001

That Council approve the recommendations outlined in Report FCSIS24-001, dated January 8, 2024, of the Commissioner of Finance and Corporate Support Services, as follows:

- a) That the Next Generation 9-1-1 project budget (2024 Capital Budget Ref #19-104) be increased by the \$2,092,800 Year 2 Next Generation 9-1-1 provincial funding allotment resulting in a total budget of \$5,490,500;
- b) That the Treasurer, in consultation with the Chief Administrative Officer, be authorized to use the non-standard procurement processes to ensure the Next Generation 9-1-1 project is expedited to enable maximum use of the Next Generation 9-1-1 funding prior to March 31, 2024, including the contracting authority to purchase all necessary items to meet Next Generation 9-1-1 requirements; and
- c) That the Treasurer be authorized to transfer up to \$500,000 from the Capital

Levy Reserve to expedite the Next Generation 9-1-1 project and that staff be directed to report back on any transfers in a subsequent report to Council.
