Subject:	Report CLSCLK18-001 Peterborough Housing Corporation Board Appointments		

## Purpose

A report to recommend appointments to the Peterborough Housing Corporation Board of Directors.

## Recommendations

That Council approve the recommendations outlined in Report CLSCLK18-001 dated June 25, 2018, of the City Clerk, as follows:

- a) That Linda Kehoe and Ken Smith be reappointed to the Peterborough Housing Corporation Board of Directors, for a 3 year term from April 1, 2018 to March 31, 2021.
- b) That Dave Tilley be appointed to the Peterborough Housing Corporation Board of Directors, for a 3 year term from April 1, 2018 to March 31, 2021.

## Background

At the Peterborough Housing Corporation (PHC) Board Meeting held April 18, 2018, the PHC Board passed the following resolution:

"On a motion by Ken Andrews, seconded by Andrew Beamer and carried, it was **RESOLVED** to recommend Dave Tilley be nominated to the PHC Board of Directors."

Linda Kehoe has over 25 years experience in Community Health and Social Services. She has experience on the Board of Directors at the YWCA Peterborough and the Art Gallery of Peterborough. Linda is currently working as a Palliative Navigator with Hospice Peterborough.

Ken Smith is retired from his career as Business and Real Estate Specialist with RBC and Loans Officer with the Community Futures Development Corporation. He has experience on the Board of Directors at Community Living Peterborough. Ken brings experience in real estate rental and property management as well as financial and budget areas.

Dave Tilley is the Manager of Operations/Fundraising for A Place Called Home, a 19bed emergency shelter in the City of Kawartha Lakes. He has worked as an Executive Assistant in the Township of Asphodel-Norwood. Dave has also served as Chair of the Board of Directors for Sunshine Homes Non-Profit Housing. Dave is replacing Larry Love on the Committee.
