# **Background**

### **Council for Persons with Disabilities**

On July 21, 2016 the Council for Persons with Disabilities (CPD) executive met with the Accessibility Office staff and the Manager of Transportation to discuss their concerns with the Handi-Van service. The Accessibility and Communication Specialist will inform CPD when the Manager of Transportation's Handi-Van review is presented to Committee of the Whole.

## **Wheel Chairs at Peterborough Memorial Centre**

Two wheel chairs were generously donated by Living Well Home Medical Equipment. These chairs will be available for visitors upon request.

## **Accessibility Audits**

As requested by the Built Environment Sub-Committee, the Accessibility Office has completed audits at 17 City facilities and 11 City parks. For each audit the operating department received a summary of quick fixes and a summary of large projects that they could consider applying to the Access Fund for.

### **Beach Access Route**

On Tuesday, August 23, 2016 the Accessibility and Communication Specialist met with the Supervisor of Parks and Forestry, Recreation Coordinator and Recreationist (Summer Aquatics, Promotion and Instructional Sports) at the Beavermead Beach and the Rogers Cove Beach. The next step is for Public Works to provide a cost estimate to the Accessibility Office. The cost estimate will include the installation of a permanent asphalt path (1.5m wide) leading from the current path near the entrance of Beavermead that would extend to the water.

## **Accessibility Reviews**

The best way to remove barriers is to prevent them. The Accessibility Office provides formal reviews during the planning and design stages of all City projects, including projects related to buildings, public spaces, services, documents, websites, by-laws, plans and policies. Recent reviews include:

- Human Resources Recruitment and Selection procedure: updated procedure
- Railway crossing on George Street at Dalhousie: retrofitted deteriorating surface
- "Shaping Our City for the Future" Strategic Framework: incorporated accessibility
- Animal by-law: incorporated service animal requirements

- Handi-Van Review: provided feedback to the Manager of Transportation
- Hilliard and Marina Road Reconstruction: accessibility review
- Capital Asset Management Plan: reviewed document format to make it accessible
- Waste Water Treatment Plan: accessibility review of proposed building signage
- Kirk Street Sidewalk: accessibility review of proposed new sidewalk
- Social Services internal newsletter: reviewed document format to make it accessible

The tool provides information for what organizations can do to go beyond compliance with Ontario's accessibility laws to create a more accessible organization.

 <u>CNIB Clearing Our Path</u> (www.clearingourpath.ca)

CNIB developed the first print edition of "Clearing Our Path" in 1998 to address the need for information on creating accessible environments for people with vision loss. The second edition of "Clearing Our Path" provided updated information based on new research, new international standards, emerging technology and universal design principles. It incorporates changes to the National Building Code of Canada and various Canadian Standards Association standards, as well as international best practices.
