#### **Council for Persons with Disabilities**

The City Accessibility Office partnered with the Council for Persons with Disabilities to celebrate National Access Week on Monday, May 29, 2017. ### **Accessibility Reviews**

The best way to remove barriers is to prevent them. The Accessibility Office provides formal reviews during the planning and design stages of all City projects, including projects related to buildings, public spaces, services, documents, websites, by-laws, plans and policies. Recent reviews and research include:

- Mason Homes subdivision, Parklands Masterplans: reviewed proposed walkway network, associated amenities, playgrounds and shade from soft landscaping.
- George Street Improvement project: reviewed layout of street, sidewalk, furniture and amenities.
- Nicholls Oval Washroom Pavilion: completed an accessibility review of the building concept #2.
- Peterborough Public Library: provided input on the interior signage package.
- Peterborough Landfill: provided input on a tender to construct a new reuse building
- Peterborough Walks Toolkit: provided input on a toolkit that will be used to complete walkability audits.
- Community Engagement Guide: provided input on how to format a guide to be as accessible as possible.
