Accessibility Reviews

The best way to remove barriers is to prevent them. The Accessibility Office provides formal reviews during the planning and design stages of all City projects, including projects related to buildings, public spaces, services, documents, websites, by-laws, plans and policies. Recent reviews and research include:

- Riverview Park and Zoo Accessibility Audit: Performed an accessibility audit with the Chair of the Built Environment Sub-Committee and a representative from Vision Loss Rehab (formerly CNIB). Provided feedback on areas such as; parking, playground, washroom facilities, paths of travel and signage.
- Service Desk Product Demo Review: Provided feedback to ensure the service desk product selected will be WCAG 2.0 compliant.
- Downtown Parking Lot Accessibility Audits: Provided information to the Parking Operations Supervisor on the legislative requirements for accessible parking spaces to improve the accessible parking in downtown City maintained parking lots.
- Public Notice for Strategic Downtown Parking Management Study: provided input on how to format the notice document to be accessible.
- Moving Conversations Pilot Walk: participated in a walkability audit of Hunter Street East, from Rogers Street to Burnham Street.
- Alternatives Peterborough Community Kitchen: partnered with Alternatives Peterborough to provide advice on how to make their new community kitchen accessible.
