BY-LAW NO. 82-2001

BEING A BY-LAW TO AMEND BY-LAW NO. 119-97-(fO
REGULATE, RESTRICT AND PROHIBIT THE KEEPING AND
RUNNING AT LARGE OF DOGS IN THE TOWN OF FORT ERIE)
FEES AND FINES

WHEREAS By-law No. 119-97 as amended, was passed by the Municipal Council of the Town of Fort Erie on the 18th day of August 1997 to regulate, restrict and prohibit the keeping and numing at large of dogs in the Town of Fort Erie, and

\WHEREAS it is deemed desirable to increase certain fees and fines contained therein;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. THAT Section 11(c) of By-law No. 119-97 be and it is hereby amended by deleting the sum of "five (\$5.00) dollars" and inserting in lieu thereof the sum of "ten (\$10.00) dollars".
2. THAT Schedule "A" to By-law No. 119-97 be and it is hereby amended under items 7, 8, 9, 10 by deleting same and inserting in lieu thereof the following:
