PURPOSE

BUDGET AND FINANCIAL IMPLICATIONS

BACKGROUND

The New Canadians Centre (NCC) started in 1979 and was incorporated as the New Canadians Centre Peterborough in 1987. The NCC is a non-profit charitable organization dedicated to supporting immigrants, refugees and other newcomers in the Peterborough and Northumberland regions. It has a mandate to:

- To ease and promote the adjustment of immigrants and refugees to Canadian Culture.
- To provide trained staff and appropriate facilities.
- To advocate on behalf of new Canadians and to provide information and referrals.
- To continually review and adjust its services to address the needs of new Canadians.
- To increase the active participation of new Canadians in determining the direction of the agency.
- To promote cross-cultural understanding and acceptance through education and awareness projects.
- To promote fundraising projects to improve quality of community services for new Canadians.

To meet its mandate, it provides language training and assessment, information and referral services, employment assistance, counseling, community bridging and education. It provides immediate assistance and orientation to immigrants and refugees when they arrive in Peterborough.

It also works closely with the Peterborough Partnership Council on Immigrant Integration (PPCII). This Council exists to promote, advance and support coordinated immigrant integration and diversity in the Peterborough community - regardless of immigrant status or any prohibited ground as outlined in the Ontario Human Rights Code and the Canadian Human Rights Act.

The NCC and PPCII believe immigrant integration and cultural diversity are essential for long-term social, cultural, economic and environmental prosperity in the Peterborough region. Together, they have designed and implemented programs and integration strategies that have a positive and meaningful impact on their clients and on our community.
