2013 CIVIC AWARDS NOMINATION PACKAGE

General Information

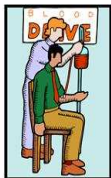
1. Nominees must be volunteers. Any remuneration of any kind for the activity in which the person is involved will make the nomination void. Professionals who are nominated while currently working in their field will not be considered. Honourable mentions will be given to staff members and paid coaches.
2. The Awards Screening Committee can only accept complete Nomination Forms. Incomplete nomination forms will be sent back to the nominator and cannot be considered by the Screening Committee.
3. A person may be nominated in more than one category and a separate nomination form must be completed for each category. However, a nominated individual will only be recognized once within a year in a specific category.
4. The activity for which a nominee is considered must be of direct benefit to that field within the City of Peterborough. A résumé of the nominees' achievements in 2013 must be included.
5. Any persons contributing to the betterment and/or bringing recognition to the City of Peterborough may be nominated for individual awards which include: Junior Athlete of the Year (male and female), Senior Athlete of the Year (male and female), Sports Personality of the Year, Youth Volunteer of the Year (male and female), and Volunteer of the Year.
6. Please ensure all names are spelled correctly on the Nomination Form. If a team is nominated please include a typewritten team list along with the coach's name, address, and telephone number. A letter of support confirming the volunteer hours and contribution made must be included and attached to any nomination.
7. Applications **must** be received by **Friday, March 7, 2014**. Any received after this date cannot be considered.
8. Nominations will be accepted through email, fax, personal delivery or mail. Phone nominations are not accepted.
9. Please read the details of each individual category as certain restrictions may apply.
10. Decisions are made solely at the discretion of the Awards Screening Committee.



2013 Civic Awards Program

Nomination Categories

1. BLOOD AND PLATELET DONATIONS



- At the time of nomination, the nominee must have donated a cumulative total of **30 units of blood** (or more) and/or **120 donations of platelets** by December 31, 2013.
 - A letter of verification from the Canadian Blood Services must accompany the nomination form. *Please note: the Canadian Blood Services will not nominate candidates.*

2. CIVIC AWARD OF MERIT - ACT OF HEROISM



- In 2013, the person must have saved a life or attempted to save a life where the nominee's personal safety was greatly endangered. This does not include medical, safety, professional rescuers or any other emergency professionals acting in the course of duty.
 - A letter of support from at least one witness other than the nominator must accompany the Nomination Form.
 - *Please note: Organ donations are not considered.*

3. COMMUNITY BETTERMENT



- The group/person must have contributed a minimum of **150 hours** in 2013 to a project that has had a considerable impact on the community at large. The nominee must have been instrumental in the project or committee.
- The nominee must have made a distinct contribution toward making the City of Peterborough a better place in which to live.
- The Nomination Form must be accompanied by a letter of verification confirming the nominee's significant contribution to the project or committee at a minimum of **150 hours** from a recognized leader or agency representative.
- Groups/persons who have received this award in the past 5 years are not eligible for recognition.

4. CULTURAL BETTERMENT AWARD



- The group/person must have made a significant contribution improving the arts, culture and/or heritage community, or by volunteering a minimum of **150 hours** to an arts, cultural or heritage organization during 2013.
 - A letter of verification from a recognized Cultural organization explaining the contributions and efforts put forth by the individual must accompany the nomination form.
 - Groups/persons who have received this award in the past 5 years are not eligible for recognition.

5. CULTURAL AWARD OF MERIT



- Nominated persons or groups must have won recognition at the provincial level or higher and brought honour to the City of Peterborough in 2013.
 - A letter of verification from a recognized cultural organization must accompany the Nomination Form.

6. CIVIC ATHLETIC AWARD OF MERIT



- Nominated person(s) or groups/teams must have won a provincial or higher championship on a Peterborough team during 2013 and brought honour to the City of Peterborough. Any coach who receives or accepts remuneration is not eligible for an award.
 - Local athletes who have won the highest level of national or international competition representing Ontario and/or Canada may be considered.
 - A letter verifying the accomplishments of the individual or team, from the sport body/sport organizer must be included with the nomination sheet.

7. SPORT BETTERMENT AWARD



- The person must have made a significant contribution improving and developing the sports community, or by volunteering a minimum of **150 hours** to sports organization(s) during 2013.
- A letter of verification from a recognized Sport organization explaining the contributions and efforts put forth by the individual must accompany the nomination form.
- Persons who have received this award in the past 5 years are not eligible for recognition.

8. FEMALE JUNIOR ATHLETE OF THE YEAR, and MALE JUNIOR ATHLETE OF THE YEAR



- The nominee must have been 18 years of age or younger at the time of competition in 2013. One award will be given in each category.
 - The young person must have demonstrated excellence, good conduct, leadership, and sportsmanship. (*The nominator must touch on these points in the submission.*)
 - The nominee must have made a **significant achievement** at the Provincial or higher level in 2013 and brought honour to the City of Peterborough.
 - A letter of verification from the sport body confirming the accomplishments must be included in the nomination submission. Emails or faxes from the Provincial Sport body will be accepted.

9. FEMALE SENIOR ATHLETE OF THE YEAR, and MALE SENIOR ATHLETE OF THE YEAR



- The nominee must have been 19 years of age or older at the time of the competition in 2013. One award will be given in each category.
 - The person must have demonstrated excellence, good conduct, leadership and sportsmanship. The nominator must touch on these points in the submission.
 - The nominee must have made a significant achievement at the Provincial or higher level in 2013 and brought honour to the City of Peterborough. Preference will be given to provincial or higher levels of competition.
 - A letter of verification from the sport body confirming the accomplishments must be included. Emails or faxes from the Provincial Sport body will be accepted.
 - Coaches are not eligible for recognition in this category.

10. SPORTS PERSONALITY OF THE YEAR



- The person must have contributed at least **300 hours** in 2013 to the promotion and development of sport in the City of Peterborough.
- The nominee must have made a significant impact on the Peterborough sports scene during 2013.
- The Nomination Form must be accompanied by at least two letters of support, from someone other than family members.

11. VOLUNTEER OF THE YEAR



- Nominees in this category must have been **22** years of age or older in 2013.
 - The person must have made an outstanding contribution to the betterment of the community of Peterborough during 2013. The person must have contributed at least **300 hours** to the volunteer initiative in 2013.
 - The nomination form must be accompanied by a minimum of two letters of support, from someone other than family members.

12. MALE YOUTH VOLUNTEER OF THE YEAR, and FEMALE YOUTH VOLUNTEER OF THE YEAR



- Nominees in this category must have been **21** years of age or younger in 2013. One award will be given in each category.
 - The person must have voluntarily contributed in a meaningful way to the development and delivery of programs and services throughout the community. The youth volunteer must have contributed at least **100 hours** of volunteer work. The individual's volunteer hours must be over and above the 40 hours of community service required by the School Board.
 - The Nomination Form must be accompanied by a minimum of two letters of support, from other than family members.

13. LIFETIME ACHIEVEMENT AWARD



- The person must have made an outstanding, continual and lasting contribution to the betterment of the City of Peterborough, not only in the nomination year but also in previous years.
- The person could be in a single volunteer capacity or involved in multiple sectors of volunteerism throughout the City of Peterborough.
- The Nomination Form must be accompanied by at least two letters of support, outlining the importance of the nominees' contribution. Letters of support must be from someone other than family members.
