Subject:	Report CSD15-007 Community Investment Grants 2015

# Purpose

A report to recommend the award of Community Investment Grants in the amount of \$210,000 to eligible community groups for 2015.

# Recommendations

That Council approve the recommendations outlined in Report CSD15-007, dated May 11, 2015, of the Director of Community Services, as follows:

- a) That the 2015 Community Investment Grants in the total amount of \$210,000 be allocated to various local charitable and Not For Profit organizations (NFP's) as set out in the attached Appendix A.
- b) That the YMCA not be considered eligible for Investment Grant funding at this time; and that Staff be directed to prepare a future report to address when and how organizations that receive large capital contributions from the City may become eligible to re-apply for City grants.
- c) That Staff also be directed to re-examine the eligibility of those organizations receiving a significant portion of their annual funding from the Trent University Student levy.
- d) That Staff be directed to prepare a report to assess whether or not Artspace should be considered for a Community Service Grant in 2016.

- e) That the 2016 financial portion of the application be revised to eliminate the use of In-kind contributions as both revenue and expenditure.
- f) That approved organizations be authorized to use the City Coat of Arms to acknowledge City support on promotional material such as flyers, brochures and posters throughout 2015.

# **Budget and Financial Implications**

Funds for this grant program were allocated in the 2015 budget process in the amount of \$210,000.

# Background

#### **Grant Advisory Committee**

A community-based Grant Advisory Committee was appointed in 2015 for a two year term (2015/2016) to review all Community Investment Grant applications and to make recommendations for the preparation of this report.

Council appointed the following individuals to the Grant Advisory Committee for a two year term: Councillor Dan McWilliams, Councillor Keith Riel, Gary Rabjohn, Jeff Westlake, Ryan Worral, Len Lifchus, Kevin Duguay, Martin Parker, Eric Prevost, Steven Soos, Glen Payne, and Kim Zippel. Kevin Duguay and Steven Soos were unable to participate in 2015 as a result of unexpected personal matters but both expect to serve in 2016.

The Grant Advisory Committee met as two subcommittees. One reviewed Environment, Health and Social Services applications (McWilliams, Parker, Prevost, Westlake, and Zippel). The other reviewed Arts, Culture, Heritage, Recreation, and Sports applications (Riel, Lifchus, Rabjohn, Worral, and Payne). City Staff administered, facilitated, and supported the process. The respective sub-committees reviewed all of the applications, applied the eligibility and evaluation criteria, and collectively hereby recommend the grant allocations as outlined in Appendix A.

#### **2015 Applications**

This year, the City received 40 applications for Investment Grant funding (including eight pre-approved multiyear requests). Four new applicants have transitioned into this program from the Project Grant program. Four former applicants did not reapply. One former applicant re-applied. One regular applicant missed the deadline. (Both will be addressed later in the report).

The following chart illustrates how the Investment Grant program has evolved since its inception.

The number of applicants and the average allocation has remained fairly constant throughout the period as a result of several applicants being redirected to either the Service Grant or the Project Grant programs. Organizations moved to the Service Grant Program include: Peterborough Historical Society/Hutchison House Museum and Kawartha Food Share, 2007; New Canadians Centre, YWCA (one year only) 2008; Market Hall, 2009; Peterborough Aids Resource Network and Peterborough Native Learning Program, 2014.

Several organizations have also dissolved including the Peterborough Arts Umbrella (2009); and more recently, Heritage Pavilion Stage (2012). This year, four organizations chose not to apply for funding including: St. James United Church, Autism Ontario, Canadian Diabetes Association, and Peterborough Drug Awareness Coalition. Since 2011, fourteen organizations have transitioned through the Project Grants into this program.

This year, the Sub-committees chose to reduce the level of funding for poor quality applications or those applications with the least impact on local residents.

#### Allocation of Funding by Sector

## Multi-year Funding

Eight organizations have been allocated funding based on previous year's approval for multi-year funding. Fourteen applicants requested multi-year funding in 2015. One is recommended for multi-year funding and thirteen are recommended for one year funding.

## YMCA Funding Request

The YMCA has not been eligible for City grant funding since receiving a major capital contribution towards its new facility in 2008 in the amount of \$2,970,000 in direct and indirect support (Capital Budget ref. 6-10.01). Last fall the YMCA was advised that it was losing its United Way funding. They asked City staff if they would be eligible for reconsideration on that basis. Staff supported an application but made no commitment. The Grant Advisory Committee reviewed the application but did not support a grant allocation at this time. They did, however, direct Staff to seek direction from Council through recommendation b).

# Eligibility of Organizations Receiving Significant Revenues from Trent's Student Levy

Several community groups receive a significant proportion of their annual revenues through Trent University's annual Student Levy. They include: Trent Radio, Kawartha World Issues Centre, and PR Community & Student Association (Sadleir House Facility). In an increasingly competitive funding environment, the Committee questioned the value of City support for what are perceived to be primarily of benefit to Trent students, especially when there are often little or no other earned revenues or fundraising efforts.

This has been a concern since the Investment Grant program was revised in 2007. As a result of an appeal in 2009, Council agreed to continue funding Sadleir House but declared the Trent Centre for Community-Based Education as ineligible (Report CSD09-023, dated September 28, 2009). Last year, the Ontario Public Research Group was declared ineligible because of its advocacy focus.

#### **Consideration of Artspace for Service Grant Funding**

Through this year's annual Investment Grant application, Artspace advised the City of the loss of 10% of its annual operating grant from the Ontario Arts Council in 2016. As one of the oldest and most successful artist-run centres in the province, they would like to be considered for a higher level of municipal funding support than the Investment Grant program provides. This potential was discussed at the sub-committee but not the overall committee level and warrants more investigation.

## Late Application

Ordinarily, late applications are not accepted. This year, however, the Peterborough Community Chaplaincy realized that it had missed the deadline by several weeks. They informed Staff that they had understood that they had been awarded three year funding in 2014, not one year. While they were invited to apply for a 2015 grant, they chose not to on that basis. Once they realized the error, they asked if they could still submit. Staff made no commitments but agreed to receive an application and present it to the committee for consideration. The Committee recommends that the Peterborough Community Chaplaincy not be awarded an investment grant in 2015 because they missed the deadline.

## **Elimination of In-kind Support Recognition**

Valuations for In-kind support, both as revenue and as expenditure, have not been considered as eligible considerations for the Investment Grant program since it was revised in 2007. It has, however, been allowed for consideration in the Project Grant program. With the number of former Project Grant recipients progressing to the Investment Grant program, they have continued to report on their In-kind support as part of their financials. Since the inclusion of In-kind support tends to inflate budgets and negate the need for earned revenues, donations, or fund-raising, it is recommended that In-kind support no longer be recognized in either program.

### **City Recognition**

In the Investment Grant and Project Grant application, organizations were asked how they would recognize the City as a sponsor, should they be successful in obtaining funding. Many indicated they would use the City Coat of Arms on their websites, flyers, and posters. Staff is requesting that permission to use the City Coat of Arms be extended to organizations to acknowledge City support.

#### **Applicant Feedback**

City Staff encourages organizations denied funding or receiving reduced funding to contact the Community Services Department administration office for feedback.

#### **Eligibility Criteria**

As a result of Reports CSD07-003 and CSD07-004 presented in the spring of 2007, Council approved significant changes to the former Community Grants Program, now referred to as the Community Investment Grant Program. Through the formal application process, applicants must meet the eligibility criteria as approved by Council:

• be NFP's that are located, and conduct the majority of their activities within the geographic boundaries of the City of Peterborough

- have sustained a history of activity over two years prior, normally achieved as past recipient of at least two Community Grants or two Community Project Grants
- have been in existence for five years if requesting multi-year funding
- have demonstrated sound financial management and good standing with the City
  of Peterborough and be able to demonstrate that they provide those services and
  programs in an effective, accessible, open and inclusive manner

The following are considered ineligible applicants:

- organizations receiving Community Project Grants or Community Service Grants
- individuals
- for-profit businesses
- organizations with political affiliation
- organizations serving as funding sources for others, e.g. Service Clubs
- faith-based organizations where services/activities include the promotion and/or required adherence to a faith
- hospitals, clinic-based services or medical treatment programs
- fund-raising events
- school boards, primary and secondary schools, post secondary institutions
- programs within legislated mandates of other government or city departments
- provincial/national organizations unless a local chapter exists to service the residents of Peterborough
- organizations receiving 80% or more of funding from senior levels of government
- organizations that conduct the majority of their activities outside of the City
- costs for major capital equipment/renovations and minor renovations; and financing of deficits

Through the application process, community groups must demonstrate:

- one or more City priorities and participant priorities within target sectors
- community need for proposed activity or service
- community support (funding support or sponsorship from other organizations, local businesses, industry, service clubs)
- community benefit/impact
- financial need (operating surpluses or reserve accounts should not exceed 25% of total operating without acceptable explanation, e.g., capital campaign)
- sound financial management and revenue generation (accurate records, responsible budget, various sources of income; if deficit, then reduction plan)
- accountability/mechanism for evaluation (identification of key performance measures and outcomes)
- feasibility (organization's ability to complete the proposed activity or service)
- evidence of community collaboration, partnerships
- impact of previous year's funding support

## Summary

This is the ninth year for the revised Community Investment Grant Program. Following the evaluation criteria approved by Council, the community-based Advisory Committee and Staff recommends the disbursement of the full \$210,000 to qualified applicants as the City's investment in their on-going activities to enrich local quality of life.
